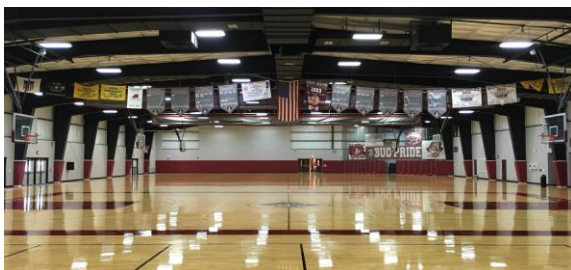

Since the summer of 2007, Scott Martin, the head boys' basketball coach at Red Bank Regional, has run summer basketball camps to help the young athletes of Little Silver, Shrewsbury and Red Bank improve their skills in a safe and fun environment. Maroon and White Basketball Camp is held at the newly renovated RBR Field House, one of the finest facilities in the state of New Jersey.

During their week at camp, players will get top-flight instruction from coaches with expertise and experience. The boys and girls will be learning the tools and techniques they'll need to improve their basketball knowledge and skills. You can expect daily station work to hone their skills, individualized instruction from the staff to improve their knowledge, and plenty of games to put into practice what they've learned at the camp.

Coach Martin, having just completed his 18th year as the Bucs' head coach, is the all-time winningest coach in school history. During his tenure, the Bucs have won two divisional titles and three Buc Classic Tournament championships. His teams have qualified 14 times for either the State and/or Shore Conference tournaments. Three-time S.C.C.A. Divisional Coach of the Year, three-time State Sectional finalist, and two-time SCT semi-finalist, the Bucs have finished in the Top 10 in the Shore eight times under Coach Martin's direction. More than fifteen of his players have gone on to play basketball in college, and three have gone on to play professionally.
